## 5. **GENERAL UPDATE**

# **Car Parking**

The major issue with car parking is that there is insufficient places for parking for the 100 berth holders and that parking permits were incorrectly linked as a form of compensation for lack of dredging. The Council have acknowledged that this is a problem and we hope to be able to work together to find a permanent solution for all berth holders. In the meantime drop off permits and quayside permits are being issued by CHT and 6 monthly permits for Gwynedd Car Parks by Gwynedd Council. VDBHA emphasise the importance of berth holders when using quayside parking to display their parking permits to enable CHT to effectively police the parking area.

## Dredging

Gwynedd Council commissioned the services of Royal Smalls, a Dutch dredging company to complete the dredging works in 2020. Unfortunately due to the lockdown travel restrictions it means that the work is unlikely to be to commence until September 2021 and will take two to three weeks to complete. The actual start date is subject to the release of lockdown restrictions, the use of the dock in the summer months and the need for winter berthing for visitor boats. Further updates on the dredging will be provided as and when they become available.

## **Berthing Fees**

CHT, in compensation for the lockdown from April to June 2020, issued a 10% refund on full payment of fees in 2020/21 or an equivalent credit amount carried forward onto the 2021/22 berthing fees. Berthing fees for 2021/22 will be raised by 1% which is set below the projected rate of inflation.

#### Toilets

The issue of the separation of the toilets remains of concern and we have assurance from Gwynedd Council that suitable facilities will be constructed when funds are available.
